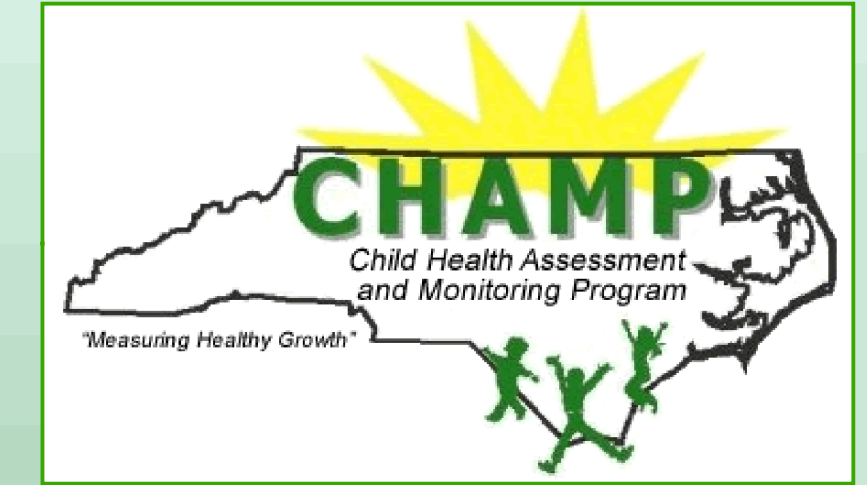




The Child Health Assessment and Monitoring Program (CHAMP) - A follow-up to the North Carolina BRFSS

Introduction

The North Carolina Child Health Assessment and Monitoring Program (NC CHAMP) survey measures the health characteristics of children.

Eligible children (birth-17 years) for the NC CHAMP survey are drawn each month from the North Carolina Behavioral Risk Factor Surveillance System (NC BRFSS) telephone survey of adults.

By collecting data on children, NC CHAMP contributes to a seamless health data system for all North Carolina citizens from birth to old age.

CHAMP Sponsors (Table 1)

- Questions to be included in the NC CHAMP survey are solicited from the North Carolina public health community on an annual basis.
- Agencies have the opportunity to sponsor questions for a fee.
- Previous sponsors include various programs and branches within the NC Division of Public Health, as well as several departments within the University of North Carolina – Chapel Hill.

Data Collection and Survey Protocol

- The State Center for Health Statistics' Survey Center administers the BRFSS and CHAMP.
- All NC BRFSS respondents with children 17 and younger living in the household are invited to participate in NC CHAMP.
- Respondents are asked when the best time to call back: daytimes, evenings or weekends.
- The NC CHAMP call is made 2-weeks after the NC BRFSS interview.
- Up to 25 call attempts are made, including Height/Weight callbacks. Eight call attempts are made on average; 51% of cases are closed out after 1-5 attempts; 71% of cases are closed out after 1-10 attempts.

Height and Weight Callbacks

- Beginning in 2007, questions have been included in NC CHAMP to assess how the respondent arrives at child's height and weight.
- Respondents who guess or did not measure child's height and weight within the past 3 months are asked if they would participate in a callback survey.
- Respondents are asked to measure the child using a measuring tape and/or scale and can either call-in to the survey center or the survey center calls back within one week.

NC CHAMP Survey (Table 2)

- The NC CHAMP 2008 survey included 109 items assessing 20 health topics.
- Average length of time to complete the 2008 survey was 20 minutes.
- 241 surveys are completed on average every month
- 1.5 surveys are completed on average for each interviewer log-on hour
- 11 dialings are made on average for each completed interview

Response Rates (Figure 1; Table 3)

- 15,835 adult respondents completed the NC BRFSS in 2008.
- 29% reported having at least one child under the age of 18 living in the household.
- 85% of NC BRFSS households with children agreed to be called back for NC CHAMP (N=3,856), of which 78% completed an interview (N=2,987).
- Overall, 65% of NC BRFSS households with children completed NC CHAMP.

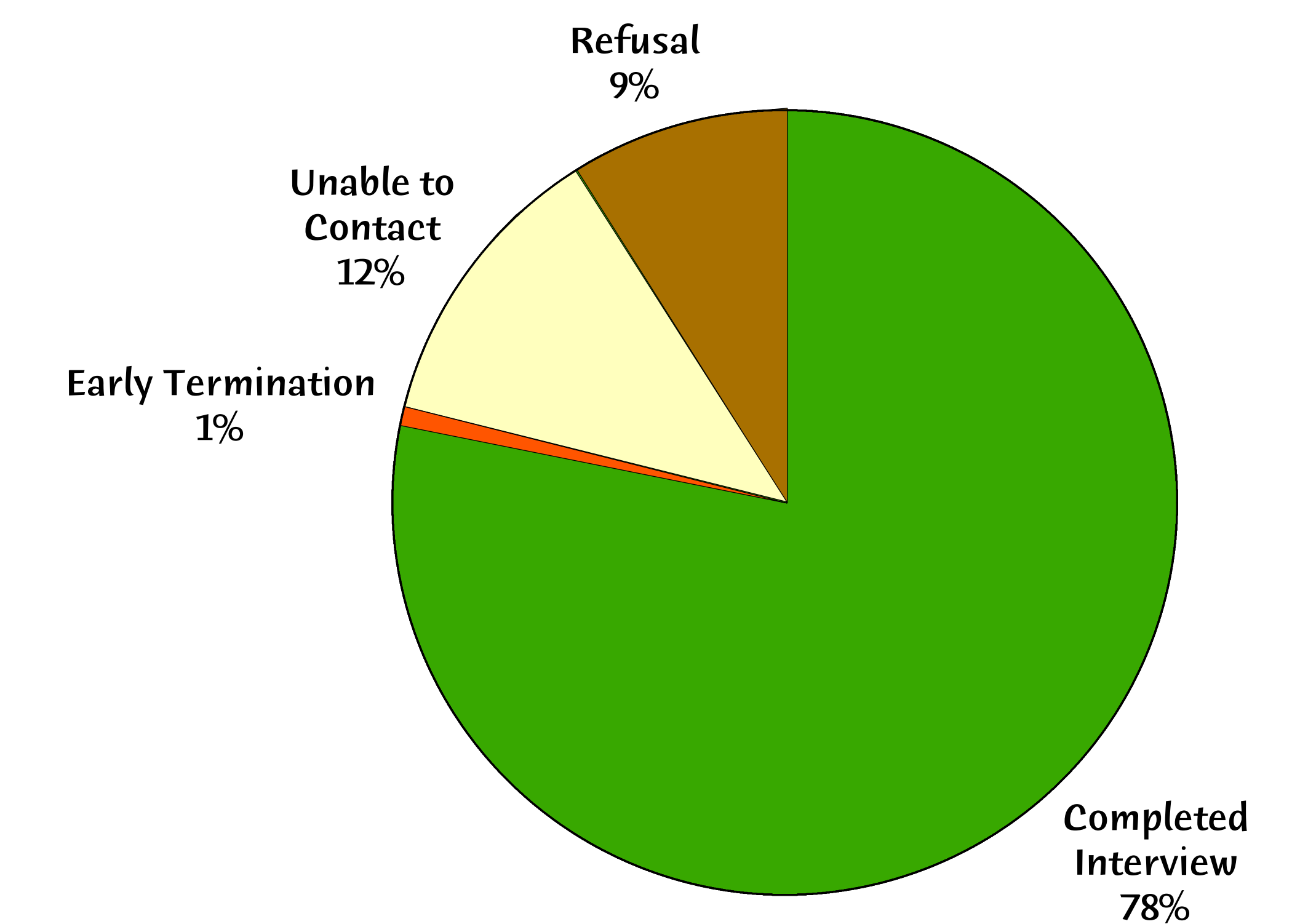
